### I. Minutes

Leslie-Bernard Joseph presented the board with the November 27, 2018 Board Meeting Minutes Draft for approval.

<u>Voted:</u> Jennifer McArdle made a motion to approve the November 27th, 2018 Board Meeting Minutes. Shona Pinnock seconded that motion, and it was approved unanimously.

### II. School Update

Leslie-Bernard Joseph and Eldridge Gilbert provided the board with updates regarding:

# IV. Growth Strategy

Leslie-Bernard Joseph proposed increasing the enrollment numbers of the organization. He talked through the current operating budget of the school and the financial trajectory resulting from growing the organization. He furthered explained the family and recruitment implications of growing the school, along with proposed locations to house a growing scholar population.

<u>Voted:</u> Jennifer McArdle made a motion to increase Coney Island Prep's enrollment numbers from 1,032 to 1,680. Joe Herrera seconded that motion, and it was approved unanimously.
